## POWERS AND DUTIES OF THE BOARD OF TRUSTEES & THE MANAGING TRUSTEE:

All the properties, funds, assets and liabilities of Trust shall vest in the Board and the Board shall be in charge of the Management of the affairs of the Trust.

The Managing Trustee shall have all the powers of administering the trust's affairs including the power to employ, regulate dismiss, remove employees, and to open and operate Bank Accounts jointly along with one of the Trustees, avail loan and execute such documents as may be required and to take such decisions to run the trust in accordance with the objectives of the Trust. The Managing Trustee shall delegate by Power of Attorney or by resolution passed in this behalf or otherwise any of the powers hereinabove specified to the Managing Trustee or Trustees or to

any other person(s) for effectively and smoothly carrying out the objects of the Trust and for proper administration of the Trust. The Managing Trustee can also delegate the powers whenever required so at his discretion. The employees of the Trust shall discharge their respective functions assigned to them under the supervision and control of the Managing Trustee

The Board may meet for transaction of business, adjourn, cancel and otherwise regulate its meetings, as it deems fit. The Managing Trustee shall be the person responsible to call the meetings of the Board and to preside over the Board Meetings. In the absence of the Managing Trustee, the trustees attending the meeting may elect one among them to preside and conduct the meeting of the Board of Trustees. The managing trustee shall be entitled to exercise a casting vote in the event of equality of votes.

The Board shall have power to augment the funds of the Trust from any source by accepting donations, and voluntary contribution or bequests of any kind subject to any conditions the Board may decide to lay down or accept.

The Trust funds shall be utilized in furthering the objects of the Trust, which include the administration of the Trust, or on objects for which the Board accumulates for a specific purpose or for incurring any capital outlay required for purposes of the Trust.

The funds belonging to the Trust or the income derived from the Trust properties shall not be utilized for any purpose other than towards fulfillment of one or more of the objects of the trust. The Income of the Trust shall not be distributed to the Members by way of Dividend, profit etc.

The funds left unexpended shall be accumulated by opting for such accumulation as the Board of Trustees decide and the funds so accumulated shall be kept invested in the manner prescribed under the existing provisions or as amended from time to time of the Indian Income Tax Act 1961 for the time being and the same shall be applied within the time up to which the accumulation is sought for on the objects for which the unexpended monies are accumulated.

The Board of trustees may meet as often as they may consider it necessary but shall endeavor to meet at least once in **three** months and the quorum at such meeting shall be two.

WITHOUT PREJUDICE TO THE ABOVE DETAILED GENERAL POWERS, THE MANAGING TRUSTEE SHALL HAVE POWERS AFTER PASSING NECESSARY RESOLUTIONS IN THE MEETING OF THE BOARD OF TRUSTEES DULY APPROVED BY OTHER TRUSTEES.

- a) To buy, sell, construct, negotiate and enter into contracts, rescind any such contracts, make advances and pay for the purpose of properties (both movable and immovable), materials, stores, equipment, machinery and other goods required for the fulfillment of the objects and purpose of the Trust.
- b) To Purchase, lease, license, let out, provide, erect, maintain and keep up lands, buildings, equipment's and materials and to sell, mortgage or dispose of properties as the trustees may think fit.
- c) To execute, become party to, sign acknowledge perfect and/or register, all deeds, documents agreements, statements, etc. and to ell, mortgage or dispose of properties as the trustees may think fit.
- d) To Borrow from time to time such sums of monies for such period on such terms with or without security s the trustees may think fit.
- e) Jointly along with one more Trustee, to draw, make, accept, endorse, discount, negotiate, execute and issue promissory notes, bills of exchange, hundies, cheques, Government and other securities and other negotiable instruments in the ordinary course of administration of the Trust.
- f) To Initiate, conduct, defend, compound, suits, to file appeals, revision, review application, to withdraw or to compromise or to adjust or to refer to arbitration or abandon any legal or other proceedings, claims or disputes, by or against the Trust or the trustees in their capacity as such or against its officers or employees concerning the affairs of the Trust before any Court,

- j) To delegate by Power of Attorney or by resolution passed in this behalf or otherwise any of the powers hereinabove specified to the Managing Trustee, and Trustee or Trustees to any other persons(s) for effectively and smoothly charring out the objects of the Trust and for proper administration of the Trust.

### **AMOUNT TO BE APPLIED ONLY IN INDIA:**

No part of the Trust's funds shall be applied outside India even if such application is for charitable purpose. None of the activities of the Trust shall be carried on outside India. It is also declared that not more than 5% of the income of the trust shall be applied for religious activities.

### **ACCOUNTS:**

The Managing Trustee shall be responsible for proper maintenance of account of the Trust. The accounts of the Trust shall be closed every year on the 31<sup>st</sup> day of March and the Income and Expenditure Account and Balance sheet, as on that date shall be prepared.

### AMENDMENTS:

The Board shall have power to frame Rules and Regulations for the Management and administration of the affairs and objects setup by the Trust Deed as they shall think fit and to alter or vary or cancel the same from time to time and to make new or additional rules and regulations. However the power to amend will not include the power to alter the Trust terms and objects. Any such amendment shall be carried out only after obtaining approval of the Director of Income Tax (Exemptions)and or the Judicial Authorities as per the Income Tax laws prevailing at that time.

The Trust shall be registered under section 12AA of the Income-Tax Act with the Director of Income-Tax (Exemptions), Chennai, and if any such Act are not found in this deed of Declaration of Trust, that may be raised by the above authority, the same shall be done by duly minuting such acts by the Board of Trustees and shall be submitted to the said authority for grant of registration under section 12AA.

# ALIENATION OF IMMOVABLE PROPERTIES:

The Board of Trustees shall ensure that any alienation of immovable property of the Trust shall be done only with the prior approval of Director of Income-tax (Exemptions) or the Commissioner of Income-Tax concerned

The Board of Trustees shall at all point ensure that its activities are always for charitable purposes and not for purposes motivated for profit.


